

## **International Communications Corporation Limited Lifetime Warranty**

Lifetime Warranty Statement: International Communications Corporation, Inc. dba ICC Networking ("ICCN") warrants its products to be free from defects in workmanship and materials, under normal use and service, for 3 years starting from the date the original purchaser purchased the product from ICCN or its Authorized reseller or distributor. Fans and internal power supplies are not included in the warranty and are covered by a warranty period of two (2) years. Should any ICCN product fail to function as warranted, ICCN may, at its own discretion, either repair or replace the defective product with a similar or functionally equivalent product, during the applicable warranty period. ICCN will endeavor to repair or replace any product returned under warranty within thirty (30) days of its receipt of the returned product.

ICCN warrants that for a period of two (2) years from the invoice date on the authorized ICCN distributor's invoice that the Software supplied by ICCN will perform substantially in accordance with the specifications set forth in the ICCN user guide accompanying the Product. In the case of a defect, which is reproducible by ICCN, the Software will be either repaired or replaced, at ICCN's option.

All products that are returned become the property of ICCN. Repaired or replacement products may be refurbished or contain refurbished materials. Any replaced or repaired product carries the remainder of the initial warranty. ICCN is not responsible for any Customer or custom software or firmware, configuration information, or memory data of Customer contained in, stored on, or integrated with any products returned to ICCN pursuant to any warranty. Customer must back up or otherwise retain any such information or data prior to shipping product to ICCN. Products returned to ICCN should have any customer-installed accessory or add-on components, such as expansion modules, removed prior to returning the product for replacement. ICCN is not responsible for these items if they are returned with the product.

Prior to returning any defective product, Customers must contact ICCN for a Return Material Authorization number. Proof of the original purchase may be required. Any product returned to ICCN without a valid Return Material Authorization (RMA) number clearly marked on the outside of the package will be returned to the customer at customer's expense.
